

# **General Purchase Order Terms & Conditions**

# 1. Scope & Order Acceptance

- 1.1 These Terms & Conditions apply to all purchase orders issued by the Company ("Buyer").
- 1.2 The Supplier must confirm acceptance of the Purchase Order (PO) in writing before it becomes binding.

## 2. Pricing

- 2.1 Prices stated in the PO are firm and exclusive of VAT, customs duties, insurance, transport, and packing unless otherwise specified.
- 2.2 No additional charges or price variations shall be accepted without prior written approval from the Buyer.

## 3. Payment Terms

- 3.1 Payments shall be made in UAE Dirhams (AED) within the agreed credit period (normally 30 days from invoice date), unless otherwise stated.
- 3.2 Late payments may be subject to interest at the rate specified in the PO.

# 4. Delivery & Logistics

- 4.1 Delivery must be made in accordance with the specifications, schedule, and delivery terms mentioned in the PO.
- 4.2 All goods must comply with applicable UAE standards and regulatory requirements.
- 4.3 The Supplier must immediately notify the Buyer of any anticipated delays.

# 5. Inspection & Quality Assurance

- 5.1 Goods supplied must meet the specifications, samples, and industry quality standards.
- 5.2 The Buyer reserves the right to inspect goods at the Supplier's premises or upon delivery.
- 5.3 Nonconforming or defective goods may be rejected and returned at the Supplier's risk and cost.

#### 6. Risk & Title

- 6.1 Risk of loss or damage remains with the Supplier until delivery and acceptance by the Buyer.
- 6.2 Title to goods passes to the Buyer only upon full payment.

# 7. Warranties & Indemnities

- 7.1 The Supplier warrants that goods are free from defects, of merchantable quality, and suitable for their intended purpose.
- 7.2 The Supplier shall indemnify and hold harmless the Buyer against all claims, damages, or expenses arising from defective goods, negligence, or intellectual property infringements.

#### 8. Cancellations & Variations

- 8.1 The Buyer reserves the right to cancel or amend a PO, subject to reasonable notice.
- 8.2 Any variation or cancellation requested by the Supplier must be agreed to in writing by the Buyer.

## 9. Packing & Transport

- 9.1 Goods must be adequately packed to prevent damage during handling and transportation.
- 9.2 Any loss or damage caused by improper packing shall be the Supplier's responsibility.

# 10. Force Majeure

10.1 Neither party shall be liable for delays or failures due to causes beyond their reasonable control, including but not limited to natural disasters, strikes, or government restrictions.

## 11. Compliance with Law

11.1 The Supplier shall comply with all applicable laws and regulations of the United Arab Emirates, including VAT, product safety, and labor laws.

### 12. Termination

- 12.1 The Buyer may terminate the PO, in whole or in part, if the Supplier fails to comply with its terms, delays delivery, or supplies defective goods.
- 12.2 The Buyer may also terminate for convenience with reasonable notice.

# 13. Governing Law & Jurisdiction

- 13.1 These Terms & Conditions shall be governed by and construed in accordance with the laws of the United Arab Emirates.
- 13.2 Any disputes shall be subject to the exclusive jurisdiction of the courts of United Arab Emirates.

# 14. Entire Agreement

14.1 The PO together with these Terms & Conditions constitutes the entire agreement between the Buyer and the Supplier and supersedes all prior communications.
